### What Data We Collect





We may collect, use, store and transfer the following kinds of personal data:

- **Identity Data**: name, title, date of birth, or similar identifiers.
- **Contact Data**: billing address, delivery address, email address, phone numbers.
- **Technical Data**: IP address, browser type and version, time zone settings, device types.
- Marketing & Communication Data: your preferences in receiving marketing and communications.

We may also collect aggregated or anonymised data (e.g. statistical or demographic data) that does not directly identify you unless combined with identifiable data.

We do not collect any special category personal data (e.g. health, religious beliefs, sexual orientation).

#### If You Don't Provide Required Data

If we need personal data to fulfil a contract or comply with a legal requirement and you do not provide it, we may not be able to deliver certain services or products.

#### Legal Bases for Processing Your Data

We will only process your personal data when legally permitted to do so, based on one or more of the following grounds:

# 1. Contractual Obligation

To fulfil or enter into a contract with you, such as processing orders or managing your account.

### 2. Consent

Where you have provided explicit consent, for example when subscribing to newsletters or marketing communications. You may withdraw consent at any time.

### 3. Legitimate Interest

Where processing is necessary for our legitimate business interests, including:

- Managing our relationship with you
- Improving our services and website
- Record keeping and compliance





# 4. Legal Obligation

Where we must comply with a legal or regulatory requirement, such as tax or law enforcement.
